MEMBERSHIP NOTICE, ACKNOWLEDGEMENT & AGREEMENT

Member further acknowledges and asserts his/her understanding that he/she is using the Club's facility at his/her own risk, and the club shall not be liable to the Member for any claims, demands, injuries, damages, or actions derived from to injury to Member's person or property arising out of Member's use of the Club facility and premises. Member hereby holds the Club, its officers, owners, agents and employees harmless from all claims which may be brought against them by Member or on Member's behalf for any such injuries or claims.

The undersigned member further understands and agrees that:

- ✓ No theft, vandalism, or violence of any type or kinds shall be tolerated in the Club facility or on the club premises; and
- ✓ No member may adjust in any manner the settings, switches, volume, etc., of the televisions and the heating/cooling units in the facility; and
- ✓ No person under the age of sixteen is to be allowed access to the Club facilities, even if accompanied by an adult member; and
- ✓ No person may use the club facilities unless that person is a member or, if the person is between the ages of 16 and 18, listed on a parent or guardian's membership; and
- ✓ No person between the ages of 16 and 18, even if listed on a parent or guardian's membership, may enter or use the club facility unless such minor is accompanied by an adult member.

Additionally, Member acknowledges that Member is to neither grant access to the Club to any other person (including other members) nor to allow anyone other than Member to use Member's personal membership number or code or access card to gain access to the Club facilities. Member understands that to do either of these prohibitions shall result in the immediate termination of the Member's membership in the Club, with no refund provided for any paid but unused membership fee. Further, to do either of these prohibitions amounts to no less than the theft of a membership and anyone doing so will be subject to fines and will be prosecuted under the fullest extent of the law.

Member further acknowledges that, except as provided directly above, the Club may, at its sole option, terminate Member's membership without fee refund for a violation of any prohibition in this Membership Notice, Acknowledgement and Agreement or for any violation of the Club Policy, provided under separate cover.
